



BIODIVERSITY NET GAIN

- A national initiative requiring developers to leave the natural environment in a measurably better state after development.
- Landowners can enhance biodiversity, support wildlife corridors and more.
- Earn between £5,000 £25,000 per Ha by enhancing habitats and selling BNG credits.
- Period of commitment: 30 years to ensure long-term biodiversity improvement.

Key Benefits for Landowners:

- Generate income by creating and maintaining biodiversity-enhancing habitats.
- Access funding to support long-term environmental stewardship.
- Strengthen ecosystems and boost local wildlife populations.

How to Get Started:

- · Identify potential habitats on your land that could be enhanced or restored.
- Contact the Birmingham & Black Country Wildlife Trust for support in the process of identifying current habitats, with potential for a free BNG survey & baseline BNG report.
- Develop a Habitat Management & Monitoring Plan and register for trading BNG credits.

BNG can increase habitat value by 10% while providing farmers a sustainable income stream.



COUNTRYSIDE STEWARDSHIP SCHEME

- · Access grants for hedgerows, woodland planting, and habitat restoration.
- Improve water quality, pollinator habitat, and soil health.
- Earn up to £1,000 per hectare for conservation-focused land management.
- Period of commitment: 5 20 years.

Example CSS Payments:

- Nectar Flower Mix (AB1): £614 per hectare
- Winter Bird Food (AB9): £732 per hectare
- Permanent Grassland with Low Inputs (GS2): £132 per hectare
- Two-Year Sown Legume Fallow (AB15): £593 per hectare

Key Benefits for Landowners:

- Receive payments for improving water quality, air quality, and wildlife habitats.
- Access grants for managing hedgerows, woodland planting, and soil conservation.
- Support pollinators and other key species by creating flower-rich habitats.

How to Apply:

- Review available Mid-Tier, Higher-Tier, and Capital Grants.
- Contact Natural England advisors for guidance.
- Submit an application through the Rural Payments Agency (RPA).

Farmers in the Countryside Stewardship Scheme receive over £200 million annually to support habitat restoration, soil conservation and sustainable farming practices!



- Earn payments for adopting sustainable farming practices
- Flexible action-based scheme that allows farmers to continue food production while enhancing environmental outcomes.
- 102 actions available from 2024, plus 14 additional actions from 2025.
- Period of commitment: 3 or 5 years, depending on the action.

Example SFI Payments:

- Flower-rich margins & in-field strips: £798 per hectare/year (3 years).
- 4m to 12m grass buffer strips: £515 per hectare/year (3 years).
- Hedgerow management: £13 per 100m/year (3 years).
- Soil health assessment & organic matter testing: £6 per hectare/year + £97 per agreement (3 years).
- Pond management: £257 per pond/year (3 years).

Key Benefits for Landowners:

- Improve soil health and reduce erosion by implementing sustainable farming methods.
- Increase profitability by enhancing land productivity sustainably.
- Access additional support for carbon storage and water quality improvements.

How to Apply:

- Review available SFI actions and choose what suits your farm.
- Start an application through the Rural Payments Agency (RPA).
- If managing SSSI land, consult Natural England before applying.

Farmers in England received over £50 million in SFI payments in the first few months of 2024, with thousands already benefiting from sustainable practices!



CATCHMENT SENSITIVE FARMING SCHEME

- Grants available up to 100% of the costs for implementing water protection measures.
- Reduce agricultural pollution and improve water quality.
- Free specialist advice on soil management, nutrient planning, & farm infrastructure improvements.
- Period of commitment: 3 or 5 years, depending on the action.

Key Benefits for Landowners:

- Helps landowners reduce agricultural pollution and improve water quality.
- Provides free specialist advice on soil management, nutrient planning, and farm infrastructure improvements.
- Grants available up to 100% of costs for implementing water protection measures.
- Commitment period varies depending on actions, typically between 3-5 years.

How to Apply:

- Contact a Catchment Sensitive Farming officer for eligibility and guidance.
- Identify areas on your land where water pollution reduction measures can be implemented.
- Apply through Countryside Stewardship or specific grant schemes.

Over 80% of farmers who worked with CSF advisors reported improved water quality and reduced pollution on their land, leading to more sustainable and productive farming!

ADDITIONAL OPPORTUNITIES & SUPPORT

• Landscape Recovery Scheme: Significant funding for long-term habitat restoration.

• Facilitation Funding: Collaborate with neighbouring landowners to increase habitat impact and access additional funding opportunities.

• Advice, support, and surveys available to determine the best option(s) for your land.


• You may be able to apply for more than one of the available grants and funding schemes if you or your land are eligible.




